### **Pre-conference** CLIMATE POLICIES IN DEVELOPING COUNTRIES, to be held on October 8<sup>th</sup>:

It is becoming increasingly clear that any new architecture for a climate protocol will involve more active mitigation by developing countries. In this perspective, CERDI and FERDI are hosting a pre-conference on CLIMATE POLICIES FOR MITIGATION IN DEVELOPING COUNTRIES, to be held on October 8<sup>th</sup>, 2014. This is an invitation for contributions to this pre-conference. Among others, contributions on the following topics are encouraged:

- Roles for developing countries in climate mitigation policies
- Taking stock on experiences in developing countries from existing instruments: REDD, CDM, PES, etc.
- New perspectives on instruments: e.g. carbon markets in emerging countries

Theoretical and applied contributions are welcome.

# For thematic sessions of the Conference, you are invited to contribute on the following topics:

- Deforestation: macroeconomic policies and deforestation, REDD and REDD+ mechanisms
- Weather insurance
- Low carbon cities in emerging countries: transport, waste management, urban sprawl
- Green economy in developing / emerging economies
- Economic valuation of the environment : stated and revealed preferences, experimental economics
- Agri-environmental policies : rural policies, farmers' behavior, land use conflicts
- Energy: biofuels, oil rent, energy technology transition and provision of energy services
- Biodiversity: instruments for conservation, protected areas, economic value, payments for ecosystem services
- International trade and the environment: foreign direct investment, competitiveness
- Institutions and governance: national and international governance, environmental treaties, corruption
- Resources management: water, fisheries
- Health and the environment
- The private sector and the environment
- Financial, economic and environmental crises

This call for papers extends to all researchers working on the above topics. However, it does not exclude other contributions in the field of environment and development. Theoretical, empirical and policy-oriented works will be considered for oral presentation.

### **Papers submission**

Full papers or work in progress written in English (at least 5 000 words) with an abstract (150-250 words), 4-5 keywords and detailed contact information (authors' names and affiliations, postal addresses and emails of presenting authors - on a separate page) should be submitted by **July 4**, **2014** at the following address: <u>http://enrmdte2014.sciencesconf.org/</u>. Authors should indicate whether they submit their paper for the pre-conference or for thematic sessions. The papers to be submitted to the pre-conference will undergo the standard refereeing process.

### **Special issue**

The editorial board of the journal *Resource and Energy Economics* has given a preliminary agreement for editing a special issue based on the papers presented at this Conference.

#### **Registration fees**

Include conference material, coffee breaks, 3 lunches, and 2 dinners. The deadline for early registration is **September 15, 2014**. After this date, higher registration fees will apply.
